K.A.R. 68-19-1 is the regulatory counterpart of K.S.A. § 65-1695. K.A.R. 68-19-1 sets out the requirements for the continuous quality improvement (CQI) program for each community retail pharmacy in Kansas. The regulation is being updated after stakeholder feedback suggested that the requirements of the CQI program could be improved upon to increase patient safety and prevent future incidents from occurring. The program is also expanded to reduce the regulatory burden for pharmacies voluntarily engaged in a patient safety organization. Updates were triggered by feedback received from the pharmacist workplace conditions survey
